Welcome & Introductions: President Torey opened the meeting by welcoming the board members and guest to the first Zoom hearing meeting of the HOA. Torey asked community manager Mark Vandervest to run the meeting. Mark moved forward to the Approval of the Agenda.

Hearing Agenda: Mark introduced Julie Morgan and gave a brief background of the noise and unauthorized pet violations that caused the request for a hearing.
